All candidates (except those were called for the 1st round) are called for the 2nd Round of Counselling and Spot Admission for B.Tech (1st Year) 2025–26 in Ceramic Technology, to be held on 17.10.2025, as per their GMR and reservation category. Candidates who were called by the college for the 1st Round of Counselling need not participate in the 2nd round.

- 5. Domicile Certificate in the format prescribed by WBJEEB [as per Section 3.4.2, Page 18 of the Information Bulletin].
- 6. SC/ST/OBC-A/OBC-B/PWD/TFW/EWS Certificate (if applicable): Respective category certificate must be submitted as per the provisions outlined in Sections 5.0 to 5.6 and Sections 6.1 to 6.2 of the Information Bulletin (Pages 19–21). OBC-A and OBC-B candidates must produce a valid and updated Non-Creamy Layer (NCL) Certificate. TFW candidates must submit an Income Certificate in the format prescribed by WBJEEB (as per Appendix-4).
- 7. Aadhaar Cards of the candidate and guardians.
- 8. Passport Size colour Photograph of the candidate.
